Program Description

Hoag invites you to attend an educational program directed towards treatment and recovery strategies for substance abuse and addiction as well as mental health. A team of experts will explore current practices, underlying causes, coping strategies, and the latest research pertaining to addiction and mental health.

This program is designed for physicians, physician assistants, licensed/certified drug & alcohol counselors, licensed clinical social workers, marriage & family therapists, nurse practitioners and registered nurses.

Program Objectives

- Recognized importance of continuing buprenorphine in the perioperative period to prevent relapse and optimally manage pain
- Analyze the unique challenges and risk factors associated with SUD and mental health issues in the older adult population
- Explain the risks of substance use/abuse during pregnancy for maternal and child outcomes
- Give examples of the specific challenges and needs of athletes, and how these can be effectively addressed through tailored psychotherapeutic approaches
- Evaluate rise of alcohol use disorder and alcohol-associated liver disease
- Describe how to properly diagnosis and manage alcohol-associated hepatitis
- Explain liver transplantation: when is the right vs wrong time?
- Gain insight into mental health challenges faced by adolescents and young adults, including biological, psychological, and social factors influencing their mental well-being. Gain insight into current trends in addiction and the adolescent and young adult populations.
- Describe the spectrum of dementia due to substance abuse and how these types of dementia differ from typical dementias
- Identify the current recommendations for laboratory and neuroimaging screening for reversible causes of cognitive impairment
- Recognize implicit bias in the language used to describe substance use disorder patients and identify current nomenclature that helps support recovery and reduces stigma
